1. 競技の観戦はスターティングホールのみです。

JJGT でも行っているように、スターティングホールでの見物、2番、3番ホール、9番ホール、及び9番ホールより10番(インコース)へ移動する際には、選手に激励の言葉、食べ物、飲み物、常用の薬、アイスノンなどを手渡すことは許されていますが、選手のキャディバッグ、クラブ類に触れることは禁止されております。当然アドバイスも厳禁です。観戦者はクラブハウス、プロショップ、レストラン、練習用のパッティンググリーン及びその周辺、ドライビングレンジ(練習場)への立ち入りは認められています。

2. 選手の健康管理・緊急の場合

原則として PJO(パールジュニアオープン)大会本部が行います。選手に緊急の場合が起きた場合、競技開催中のコース内に入ることが出来ます。詳しいことは競技が始まる前に JJGT 大会役員にお申しつけ下さい。常備薬を忘れずに！また、暑さ対策も日本を出発される前に充分ご留意ください。

3. ドレスコード

- ・男子・女子とも襟付きのシャツを着用し、ズボン、スカートなどにタックインしてください。スイングのためにシャツが上がってしまう場合もありますが、スイング以外の動きには常備タックインを心がけてください。
- ・極度に短いショーツは禁止されています。膝上10センチまでが基準となっています。(余談ですが、USLPGA の選手の中にはこの規定に違反している有名プレーヤーが10数名います)。
- ・UVCUT(紫外線カット)のサングラスの着用は許可されています。
- ・キャップ・サンバイザーの着用をお勧めします(強制はしていません)。
- ・距離だけの測定器の使用は認められています。(高低は禁止)
- ・その他、試合中、練習器具などは誤解の元になりますので、携行しないほうがよいでしょう。

4. 試合会場までの交通手段

練習ラウンド及び大会3日間はチャーターバスにて団体行動となります。遅いティータイムで一緒に行動しない場合は、自分でタクシーにて来場してもらいます。できる限り、TeamMate を応援するためにも団体行動にしましょう。

5. 競技は担ぎか、手引きカートで行います。手引カートの貸し制度はありませんので、日本から持ち込むか、現地で調達する必要があります。ハワイ入国日にプロショップに立ち寄ります。

6. 表彰式

3日目の競技終了後 Buffet Banquet にて表彰式が行われます。選手は夕食をとりながら表彰式セレモニーに臨みます。保護者も所定費用を支払って表彰式に参加できます。もちろん Buffet 式のディナー付きです。

PEARL JUNIOR OPEN

CHAMPIONSHIP PACE OF PLAY POLICY

The PJO Championship Pace of Play Policy utilizes a two checkpoint system.

- Each group is responsible for monitoring their own pace.
- To avoid penalty, groups must complete each checkpoint hole:
 1. Under the allotted time, or
 2. Within 15 minutes of the group ahead.
- Checkpoints will be on holes #4, 9, 13 and #18, unless otherwise indicated.
- All players in a group in breach of the pace of play policy at any checkpoint are subject to penalty.

PENALTIES

First Violation = Yellow Warning Card ("warning") to each player in the group.

Second Violation = Red Warning Card, 1 stroke penalty to each player in the group.

Third Violation = Red Warning Card, 2 stroke penalty to each player in the group.

Fourth Violation = A third Red Card could result in disqualification.

NOTIFICATION

Any group that completes a checkpoint hole in breach of the pace of play policy will be notified by an Official. Officials at checkpoints should never be confronted.

It is the player's responsibility to record and include any penalties assessed on their scorecards. Penalties are to be added to the checkpoint hole where the breach occurred. (usually holes #9 or #18)

POSITION

First group(s) off either tee – The first group(s) will be in breach of the pace of play policy if they take more than the allotted time to finish a checkpoint hole until they reach (within 15 minutes) any group ahead. After they reach a group ahead, both conditions must be met to be in breach of the pace of play policy.

Position with group ahead – To stay within 15 minutes of the group ahead, players should never have an open hole and they should be in the fairway on Par 4's and 5's when the group ahead leaves the green.

CONCERNED PLAYERS AND APPEALS

A player concerned about slow players in a group should first remind that player of the pace of play policy and encourage them to play more efficiently. The concerned player may, before or after penalties are assessed, request an Official to monitor the group.

Appeals for exceptional situations will be considered only in the scoring area after the completion of the round and prior to the return of a player's scorecard.

DEFINITIONS

Timing – A group's completion time at each checkpoint is measured when the flagstick is replaced in the hole once all players in the group have holed out.

Allotted Time – The "allotted time" is the maximum time allowed to complete play of the course of the holes between checkpoints. The allotted time is predetermined by the Tournament Committee and may be adjusted between rounds. Time for ball searches, rulings and walking or travel time between holes is included in the allotted time. The allotted time for each course will be posted on the notice to competitors or on a pace of play policy sheet for the tournament.

Rule 6-7. Undue Delay; Slow Play states: "The player must play without undue delay and in accordance with any pace of play guidelines that the Committee may establish. Between completion of a hole and playing from the next teeing ground, the player must not unduly delay play."

NOTICE TO COMPETITORS

10 YRS OLD AND YOUNGER: OJGA TEES 11-12 YRS OLD BOYS & GIRLS: RED TEES
13-18 YRS OLD GIRLS & 13-14 YRS OLD BOYS: WHITE TEES 15-18 YRS OLD BOYS: BLUE TEES

INFORMATION:

- **FORMAT OF PLAY:** This is a 54-hole Stroke Play event (36 hole for 10 & under). The Tournament committee reserves the right to shorten the tournament due to inclement weather or unplayable conditions due to inclement weather.
- **YARDAGE MARKERS** are measured to the center of the Greens.
100 Yard Markers: Indicated by red markers embedded in the fairways.
150 Yard Markers: Indicated by yellow markers embedded in the fairways.
200 Yard Markers Indicated by blue markers embedded in the fairways.
- **DOUBT AS TO PROCEDURE:** When doubtful of one's rights or a procedure, the player may apply RULE 20.1c(3) and play a second ball without penalty. The player shall report the facts to the Committee before turning in his scorecard unless he scores the same with both balls. Failure to report will result in disqualification. Please review RULE 20.1c(3) **PLAYING 2 BALLS WHEN UNCERTAIN WHAT TO DO**
- **DRESS CODE:** All players and spectators must adhere to the OJGA Dress Code as stated in the OJGA Handbook located at www.ojga.org.
- **CODE OF CONDUCT:** All players must adhere to the OJGA Code of Conduct as stated in the OJGA Handbook located at www.ojga.org.
- **FINAL ROUND TEE TIMES** will be emailed to the players, posted in the Pearl Country Club Pro Shop. Tee times may also be obtained by calling (808) 462-9797.

CONDITIONS OF COMPETITION: USGA Rules of Golf effective January 2023 govern play

1. Specifications of Clubs and the Ball
 - a) Only drivers on the current USGA List of Conforming Driver Heads may be used.
 - b) Only golf balls on the current USGA list of Conforming Golf Balls may be used.Penalty for use of clubs not on the above list(s) - Disqualification.
2. No practice between holes: Between the play of two holes, a player shall not play any practice stroke on or near the putting green of the hole last played.
3. **Devices that measure distance only will be allowed.** Devices that have slope measuring capability are not allowed. GPS devices that have multi-function capabilities (i-phone, smart phone, i-pad etc.) are not allowed.
4. Pace of Play. All players are asked to finish their round in 4 ½ hours or less.
5. **Upon Completion of Round, players should proceed directly to the designated "scoring area/table".**
6. Signed and attested scorecards must be turned in within 10 minutes of completion of round. Subject to disqualification.
7. **TIES:** Winners for each age division will be decided by a sudden death playoff from hole(s) to be decided by committee, **if time allows**. Otherwise, ties will be broken by USGA recommended method,
8. (c). Close of Competition. The competition shall be deemed to have closed when all scores have been approved by the Rules Committee. In the event of a playoff, the competition shall be deemed to have closed when the playoff scores have been approved by the Rules Committee.

In addition, the following conditions are in effect:

PACE OF PLAY: (Rule 6-7 Undue Delay)

Please Keep up with the group in front of you. You are deemed to be out of position if there is more than a one (1) hole opening in front of your group AND your group is beyond your allotted time.

1st offense: Warning-YELLOW Card

2nd offense: 1 stroke penalty-RED Card

3rd offense: 2 stroke penalty-RED Card

4th offense: Disqualification-RED Card

LOCAL RULES:

1. **OUT OF BOUNDS:** The Perimeter or outer boundary of the golf course is OUT OF BOUNDS as defined by white stakes, white lines, or inside edge of fence post at ground level.
2. **DRIVING RANGE:** entire driving range is OB as designated by white stakes, white line or fence post
3. **HOLE #7:** Out of Bounds on the left as marked (*Local rule NOT in effect, No Drop Zone*)
4. **GROUND UNDER REPAIR:** is defined by enclosed white lines around the affected area. Players are entitled to relief under USGA Rule 16.1
5. **IMMOVABLE OBSTRUCTIONS:** Any area that is marked with white paint adjacent to a cart path is considered an extension of the cart path (immovable obstruction) and player is entitled to relief under USGA Rule 16.1. The flowerbeds behind the green of holes #9 and #12 as well as all irrigation control boxes are considered immovable obstructions and the player is entitled to relief under Rule 16.1.
6. **RED PENALTY AREA:** margins are defined by red stakes and/or red lines. Stakes and lines are in the Penalty Area.
 - a. **RELIEF FROM RED PENALTY AREA ON HOLE #5:** When taking relief from the lateral water hazard on hole #5, where the cart path is immediately adjacent to the lateral water hazard, the player may proceed to the left side of the cart path and drop within one (1) club length of a point no nearer to the hole than where the ball last crossed the margin of the lateral water hazard (*ONE STROKE*).
 - b. **RELIEF FROM RED PENALTY AREA BEHIND GREEN ON HOLE #6:** If a player's ball is in the area marked as a lateral water hazard behind the green, starting from the water hazard margin marked on the cart path to the right of the green on Hole #6, the player may, as an additional option under Rule 17, under penalty of one stroke, drop a ball on the area marked as a Drop Zone to the right of the green.
7. **YELLOW PENALTY AREA:** are defined by yellow stakes and/or lines. Stakes and Lines are in the Penalty Area
8. **RANGE BALLS ON COURSE:** The hitting of practice balls back toward the range during the play of a hole will constitute a breach of Rule 5.5a
9. **SHUTTLES:** Shuttles may be provided only for the 10 and Under players between holes 4 and 5, 6 and 7, 15 and 16. All other age divisions will be shuffled as deemed necessary by committee.

DROP ZONES: There will be a Drop Zone on hole(s) #6 Hole over the green (see local rule 6b)

Etiquette

1. Help fellow competitors locate golf balls.
2. Properly Rake all bunkers
3. Repair ball marks and divots
4. Please be sure to thank ALL volunteers; scorekeepers, spotters (if any), shuttles (if any), players assistants, rules officials, score table, score board, starters.

Please leave the golf course in the condition you found it in and enjoy your round
